MANAGEMENT TRANSACTION

Lisbon, March 13th, 2020: Pursuant to the terms and for the purposes of article 19 of Regulation (EU) no. 596/2014 of the European Parliament and of the Council and of article 248-B of the Portuguese Securities Code, EDP - Energias de Portugal SA ("EDP") provides the following information to EDP:

João Manuel Veríssimo Marques da Cruz, member of EDP's Executive Board of Directors, informed that, following the early redemption by EDP of all the outstanding Notes of the "€750,000,000 Fixed to Reset Rate Subordinated Notes due 2075", which occurred on March 2nd, 2020, ceased to hold two Notes representative of such issue with a nominal amount of 100,000 euros per Note.

As a consequence of the early redemption referred above, João Manuel Veríssimo Marques da Cruz is no longer holder of Notes representing the "€750,000,000 Fixed to Reset Rate Subordinated Notes due 2075".
