MANAGEMENT TRANSACTION RELATED WITH THE ACQUISITION OF SHARES IN THE OVERSUBSCRIPTION BY MEMBER OF THE EXECUTIVE BOARD OF DIRECTORS

Lisbon, August 19th, 2020: Pursuant to the terms and for the purposes of article 19 of Regulation (EU) no. 596/2014 of the European Parliament and of the Council, of article 10 of the Delegated Regulation (EU) no. 2016/522 of the Commission and of article 248-B of the Portuguese Securities Code, EDP - Energias de Portugal, S.A.
