Background Context

This year concludes the UN declared Decade of Sustainable Energy for All 2014-2024.

The world's capacity to generate renewable electricity has expanded faster than at any time before. However, the world must accelerate emissions reductions efforts globally to reach carbon neutrality by 2050, to secure IPPC's lower risk scenario of 1.5°C, while it adapts to the ongoing adverse climate change. This mission is even more imperative this year, as we navigate governmental election results globally and build wider trust in the value of the energy transition.

Electrification, industrial decarbonization and the expansion of data centers and AI are set to drive exceptional demand growth. Renewables acceleration, as well as energy efficiency, play a critical role in addressing this surge in demand to avoid locking in investments in projects with high-emitting GHGs.

The energy transition stands at the heart of the business strategy of EDP- the world's most sustainable electric utility by S&P Global CSA. 98% of the energy we generate worldwide comes from renewable sources compared with only 20% two decades ago. We aim to be all green by 2030 as we deploy our 17 billion euros investment plan within 2024-2026.

Together we can maximize efforts to enhance the clean energy transition. There are great solutions being deployed from diverse business sectors and civil society, and also examples of adequate financial and regulatory frameworks. Businesses are calling out to governments to deliver favorable regulatory policies that will ensure stability and pave the way forward for accelerated clean tech investment.

This breakfast and roundtable meeting titled "The Energy Transition: From Rhetoric to Reality" brings together an exclusive group of influential voices and business leaders across various industries and the financial sector, to discuss the resilience and acceleration of the energy transition amidst current challenges such as macroeconomic fluctuations, political uncertainty, disruptions on supply chain, availability of skilled workforce, interconnection queues and regulatory and fiscal uncertainty.

To facilitate an informative discussion, this event will be held under "Chatham House Rules" and will be moderated by Vijay Vaitheeswaran, Editor at *The Economist*. 
