MANAGEMENT TRANSACTION

Lisbon, November 14th **2016:** Pursuant to the terms and for the purposes of article 19 of Regulation (EU) No. 596/2014 of the European Parliament and of the Council and of article 248-B of the Portuguese Securities code, EDP - Energias de Portugal S.A. ("EDP") provides the following information to the market:

- Mr. António Luís Guerra Nunes Mexia, Chairman of the EDP Executive Board of Directors, informed EDP that, on the past November 10th, 2016, has acquired 10,000 shares of EDP share capital, at a price of 2.789 euros per share.
