## MANAGEMENT TRANSACTION

**Lisbon, November 24<sup>th</sup> 2016:** Pursuant to the terms and for the purposes of article 19 of Regulation (EU) No. 596/2014 of the European Parliament and of the Council and of article 248-B of the Portuguese Securities code, EDP - Energias de Portugal SA ("EDP") provides the following information to the market:

1. Mr. António Fernando Melo Martins da Costa, member of EDP Executive Board of Directors, informed EDP that, on November 22<sup>nd</sup>, 2016, he has acquired 20,000 shares of EDP share capital, at a price of 2.735 euros per share.
