MANAGEMENT TRANSACTION

Lisbon, November 14th 2016: Pursuant to the terms and for the purposes of article 19 of Regulation (EU) No. 596/2014 of the European Parliament and of the Council and of article 248-B of the Portuguese Securities code, EDP - Energias de Portugal SA ("EDP") provides the following information to the market:

1. Mr. Rui Manuel Rodrigues Lopes Teixeira, member of EDP Executive Board of Directors, informed EDP that, on the past November 11th, 2016, has acquired 1,000 shares of EDP share capital, at a price of 2.709 euros per share.
2. Following the above-mentioned acquisition, Mr. Rui Manuel Rodrigues Lopes Teixeira holds 8,333 shares of EDP's share capital.
