# BLACKROCK NOTIFICA PARTICIPAÇÃO QUALIFICADA NA EDP

**Lisboa, 28 de Novembro de 2019:** Nos termos e para os efeitos do disposto no artigo 244º do Código dos Valores Mobiliários e do Regulamento n.º 5/2008 da CMVM, a EDP – Energias de Portugal, S.A. (“EDP”) vem prestar a seguinte informação ao mercado e ao público em geral:

No dia 27 de Novembro de 2019, a BlackRock comunicou à EDP, nos termos do artigo 20.º do Código dos Valores Mobiliários (CVM), que detém uma participação qualificada de 5% do capital social e dos direitos de voto da EDP. O patamar de 5% foi ultrapassado pela BlackRock no dia 26 de Novembro de 2019.
