MANAGEMENT TRANSACTION RELATED WITH THE ACQUISITION OF SHARES BY MEMBER OF THE GENERAL AND SUPERVISORY BOARD

Lisbon, August 4th, 2022: Pursuant to and for the purposes of Article 19 of Regulation (EU) No. 596/2014 of the European Parliament and of the Council, of Delegated Regulation (EU) No. 2016/522 of the Commission and in Article 29-R of the Securities Code, EDP - Energias de Portugal, S.A.
