## MANAGEMENT TRANSACTION

**Lisbon, November 17<sup>th</sup> 2016:** Pursuant to the terms and for the purposes of article 19 of Regulation (EU) No. 596/2014 of the European Parliament and of the Council and of article 248-B of the Portuguese Securities code, EDP - Energias de Portugal SA ("EDP") provides the following information to the market:

1. Mr. Fernando Masaveu Herrero, member of EDP's General and Supervisory Board, informed EDP that, on November 14<sup>th</sup>, 2016, the following closely associated persons acquired shares of EDP share capital:
