ORISE S.A.R.L. (“ORISE”) an entity fully owned by Kindbright Holdings Corp. Limited, which in turn is fully owned by CNIC Co., Ltd. (formerly designated Guoxin International Investment Co., Ltd), announces it intends to sell 48,783,722 shares (the “Shares”) representing approximately 1.33% of the share capital of EDP – ENERGIAS DE PORTUGAL, S.A. (“EDP”).

Accordingly, ORISE hereby announces that it is launching a private placement of the Shares via an accelerated bookbuild addressed exclusively to qualified institutional investors (the “Placing”).

Upon completion of the Placing, ORISE will retain 3,000,000 shares in EDP which will be subject to a 30 days lock-up.

Société Générale is acting as Sole Bookrunner in respect of the Placing.

The final terms of the Placing will be announced upon completion of the accelerated bookbuild procedure which is expected to occur prior to market opening tomorrow.
