CANADA PENSION PLAN INVESTMENT BOARD ("**CPPIB**"), a corporation registered in Canada and having its registered address at One Queen Street East, Toronto, Ontario, Canada, announces that it has successfully completed the sale, by way of a private placement via an accelerated bookbuild addressed exclusively to qualified institutional investors (the "**Placing**"), of 218,488,895 shares (the "**Shares**") representing approximately 5.2% of the share capital of EDP, S.A. ("**EDP**"), in accordance with the previous announcement issued on 10 November 2025.

The Placing's total gross proceeds reached approximately €814,745,089 corresponding to a price of €3.729 per Share.

Settlement of the Placing shall occur on 13 November 2025.

Goldman Sachs & Co. LLC ("**Goldman Sachs**") acted as sole bookrunner of the Placing.
